RafflesMedicalGroup Starts 2011 with Double Digit Growth and Record Revenue of S\$64.4 million

Singapore, **28 April 2011** – *RafflesMedicalGroup*, ("Group") a leading integrated private healthcare provider in Singapore and the region, started the year with double digit growth at its key divisions.

The Group's revenue grew **14.7%** from **\$\$56.2** million for Q1 2010 to **\$\$64.4** million for Q1 2011. Both Hospital Services and Healthcare Services divisions had strong growth, increasing revenue by **15.0%** and **14.4%** respectively.

Profit after tax for the Group increased 15.7% from \$\$9.1 million in Q1 2010 to \$\$10.6 million in the same quarter this year. Excluding the impact of jobs credit grants received by the Group in Q1 2010, profit after tax for Q1 2011 would have grown by 21.9%. A growing patient load, wider range of medical specialties and improved operating efficiencies saw operating profit increase to \$\$12.8 million.

Strong cash flow from operating activities contributed an additional **\$\$12.3 million** to the Group's healthy net cash position which at 31 March 2011 stood at **\$\$71.0 million**.

RafflesHospital added more doctors to its pool of consultant specialists. New staff specialists in obstetrics & gynaecology, radiology and dental surgery joined the hospital in Q1 2011. With these new additions, the hospital strengthened its clinical services, programmes and competencies in areas sought after by patients.

RafflesHospital's foreign patient load continues to increase. The foreign patient base is well diversified with patients coming from more than 100 countries. Focusing on quality and value-driven curative healthcare services, **RafflesHospital** is expected to contribute further to the Group's performance.

RafflesHospital's formal application for the additional 102,408 square feet expansion is

expected to be submitted to the Urban Redevelopment Authority by Q3 2011. With the

additional space, its existing clinical services can be further expanded while new facilities

and services can be developed to boost the hospital's service offerings.

The purchase of the 42,668 square feet, 7 storey freehold podium/commercial block of

Thong Sia Building was completed on 15 April 2011. A comprehensive Specialist Medical

Centre will be established there to provide another convenient location for patients seeking

specialist services in the Orchard area. The Medical Centre is expected to commence

operations in 2012.

Three new RafflesMedical clinics at Asia Square, I12 Katong (former Katong Mall) and

Changi City Point are scheduled to open in the second half of 2011, further expanding its

network of clinics and making it more accessible and convenient for our patients and

corporate clients.

The buoyant local economy bodes well for Raffles Medical as it continues to offer

comprehensive services and cost-effective solutions to corporate clients and individual

patients.
