RafflesMedicalGroup to Open New Multi-Disciplinary Medical Centre at Shaw Centre in June 2015 Group Posts Record 1st Quarter Revenue

Singapore, 27 April 2015 – *RafflesMedicalGroup* ("Group"), a leading integrated private healthcare provider in Singapore and the region announced the opening of a multi-disciplinary medical centre at the newly revamped Shaw Centre in June 2015.

The centre will bring family medicine, dental, health screening and a full range of specialist services to the heart of the Orchard and Scotts shopping and tourist belt, to meet the needs of local, expatriate and foreign patients. *RafflesChineseMedicine* will also open a clinic at the centre, marking its first foray outside *RafflesHospital*, where its main clinic is located.

Financially, the Group maintained a healthy growth in revenue of **8.5%** from **\$\$87.6** million in Q1 2014 to **\$\$95.0** million in Q1 2015, a new high for first quarter revenue.

All divisions contributed positively to the growth of the Group with revenue from Healthcare and Hospital Services divisions increasing **13.7%** and **6.2%** respectively. This is driven by an expanding primary care network and the addition of more specialists at the hospital in the areas of endocrinology, plastic surgery and haematology.

Profit from operating activities increased by **2.6%** to **S\$17.7** million in Q1 2015 from **S\$17.2** million in Q1 2014. The increased profit was attributable to higher revenue from increased patient load. More doctors, specialists, nurses and ancillary staff were recruited for new and expanded operations at *RafflesHospital* and upcoming new medical centres at Shaw Centre and *Raffles Holland V*. The Group's net profit after tax increased by **2.8%** to **S\$15.1** million in Q1 2015 from **S\$14.6** million in Q1 2014.

Cashflow from operations remain strong with the Group in a healthy cash position of **S\$120.9** million as at 31 March 2015. This is after accounting for payment of S\$44.0 million for investment properties under development and S\$3.5 million in capital expenditure.

RafflesHospital is expected to grow with the expansion of the Cardiology, Surgery, Urology, ENT and Cancer clusters and the introduction of bone marrow transplant services. As patient demand for services continue to grow, the enlarged centres and introduction of new specialist services will see **RafflesHospital** increasing the breadth and depth of services to its patients.

Construction works for the *RafflesHospital Extension* commenced in December 2014. When completed in the first quarter of 2017, the new 20-storey medical tower together with the existing hospital building will constitute an integrated medical complex offering significant scope for *RafflesHospital*'s expansion and growth over the next 10 years.

The development of *Raffles Holland V* is on track and expected to be completed in the first quarter of 2016. Approximately 9,000 square feet will be dedicated to the expansion of the Group's medical and specialist services to cater to both local and expatriate patients. The remaining commercial space will be leased to DBS Bank and other tenants offering specialty lifestyle, food and beverage and retail services.

RafflesMedical and **RafflesDental** are expected to continue to benefit from the government initiated Community Health Assist Scheme (CHAS), Pioneer Generation (PG) package and the Flexi-Medisave scheme. The majority of the Group's family medicine and dental clinics are accredited to serve Singaporeans under CHAS and PG. The opening of a new family medicine and dental clinic at Eastpoint Mall will also offer more convenience to our patients and corporate clients.

The collaboration with Ministry of Health (MOH) whereby *RafflesHospital*'s Emergency Department (ED) will receive patients from Singapore Civil Defence Force emergency ambulances is expected to commence by mid-2015.

The more measured pace of economic growth in the region and Singapore may have a dampening effect on healthcare demand. With the planned completion of the *Raffles Holland V* and *RafflesHospital Extension* projects, the Group is well-positioned for the future. The Group will stay vigilant and proactively respond to new opportunities that may arise.

Says Dr Loo Choon Yong, Executive Chairman of *RafflesMedicalGroup*: "Raffles has a significant number of patients who live in Districts 9, 10 and 11. These patients would find the medical centre at Shaw Centre and *Raffles Holland V* to be a convenient location to access the comprehensive and integrated medical services offered by the Group."
