**RafflesMedicalGroup Reports Healthy Results in Q2 2012**

Singapore, 23 July 2012 – **RafflesMedicalGroup**, (“Group”) a leading integrated private healthcare provider in Singapore and the region, reported a healthy set of results in the second quarter of 2012. Revenue grew **14.9%** from **S\$67.0** million in Q2 2011 to **S\$76.9** million in Q2 2012. All divisions contributed positively, with Hospital Services and Healthcare Services divisions registering growth of **19.1%** and **9.1%** respectively.

The Group’s net profit after tax grew **7.1%** to **S\$12.5** million in Q2 2012 from **S\$11.7** million in Q2 2011. As at 30 June 2012, the Group had a healthy cash position of **S\$84.2** million from the continued strong operating cashflow of the Group.

To meet the expanding needs of the Group, more specialists, family physicians, dental surgeons, nurses and support staff were recruited. Wages were raised in line with industry wide salary adjustments. These factors saw staff costs increasing by **19.1%** comparing Q2 2012 to that of Q2 2011.

**RafflesHospital** recruited new specialist consultants in Paediatrics, Obstetrics & Gynaecology, General Surgery, Neurosurgery, Neurology, Gastroenterology, Psychiatry, Radiology, Nuclear Medicine and Periodontics. This facilitates the development of more clinical integration programmes to benefit our patients.

**RafflesHospital’s** continuing focus on high quality curative healthcare services contributed positively to its strong growth. Its strong brand equity, widening foreign patient base, competitive pricing and established multi-disciplinary specialist care continue to drive its growth.

The Group is working with consultants to finalise plans for the two projects announced previously - the expansion of **RafflesHospital** by an additional 102,408 square feet, and the expansion of specialist outpatient services at 30 Bideford Road.

An expanded HealthCheck Clinic, opened at **RafflesHospital** in April this year. The clinic offers dedicated services for statutory medical examinations and related employment check-ups.

**RafflesMedical**, one of the largest primary care clinic networks in Singapore, relocated its flagship clinic at Raffles Place to larger premises in Singapore Land Tower. New services in Health Screening and Executive Medical services were added to complement the existing General Practice, Dental and Women's services.

**RafflesDental** moved its Specialist Dental Centre at the hospital to larger premises on the ground floor to accommodate more dental chairs and new state-of-the-art equipment, and to provide a wider range of sub-specialty dental services.

**RafflesMedical** Shanghai continues to grow well with new services in Psychiatry, Paediatrics, Dentistry and TCM.

Dr Loo Choon Yong, Executive Chairman of **RafflesMedicalGroup** says, "There is no doubt that the healthcare landscape will remain competitive with new public and private hospitals coming on stream in the next few years. We are, nevertheless, confident that patients and clients appreciate our established brand of healthcare, and that we will continue to grow."
